## **Speakers Biographies**

Christopher Catling, the Secretary, Royal Commission on Ancient and Historical Monuments of Wales. Christopher chairs the Welsh Historic Places of Worship Forum, which is made up of representatives of the main faith groups in Wales. The Forum's aim is to help congregations respond effectively to the challenges they face in maintaining historic places of worship. **Becky Clark** is Director of Churches and Cathedrals at the Church of England and Secretary of the Church Buildings Council and Cathedrals Fabric Commission for England. She trained as an archaeologist and has an MA in Heritage Management from the Ironbridge Institute and an MBA from Warwick Business School. Becky previously worked for English Heritage in the planning policy team and Chief Executive's Office, and before that at the National Trust's Stourhead estate. He is also the Secretary to the Committee on Church Art and Architecture – the Committee who oversee all applications for alterations to the interior of places of worship.

His background is primarily in community development, theology and facilitation – with a particular focus on how liturgy and buildings shape the way we gather.

He is currently working on a pilot project – <u>Unlocking the Next Economy: Churches and Community Enterprise</u> — to use church buildings for community enterprise in the South West of England, with plans for a national conference and campaign in autumn 2018. Susan is also a Reader (Licensed Lay Minister) in the Southwell and Nottingham diocese.

lan Simpson MBA CBIFM, Heritage Officer, Diocese of Liverpool lan is the Diocese of Liverpool's Heritage Officer, a position in which he has helped many of the Diocese's churches secure grant funding (£5m to date) for major repair projects. He runs training courses on maintenance and fund raising, and advises churches on everything from welcoming visitors and tourists to eradicating dry rot and Japanese knotweed.
